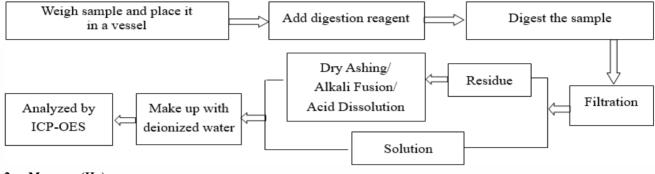

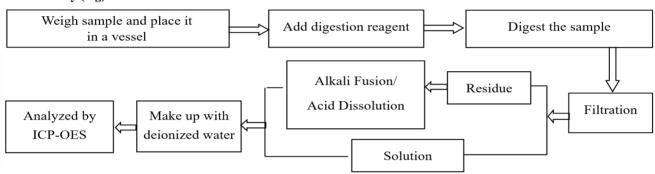

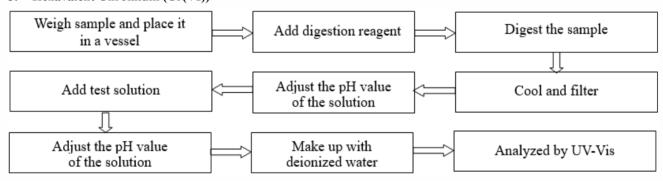


#### 2. Mercury (Hg)

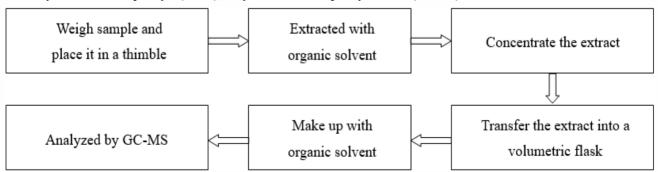
